C19 BUSINESS NEWS UPDATE

MORE SPACE FOR CYCLISTS AND PEDESTRIANS

The Government has released details on its guidance for Local Authorities on managing their road networks in response to C19.

The Secretary of state for Transport comments:

"The coronavirus (COVID-19) crisis has had a terrible impact on the lives and health of many UK citizens, as well as severe economic consequences. But it has also resulted in cleaner air and quieter streets, transforming the environment in many of our towns and cities.

And millions of people have discovered, or rediscovered, cycling and walking. In some places, there has been a 70% rise in the number of people on bikes - for exercise, or for safe, socially distanced travel.

When the country gets back to work, we need them to carry on cycling, and to be joined by millions more. With public transport capacity reduced, the roads in our largest cities may not be able to cope without it.

We also know that in the new world, pedestrians will need more space. Indications are that there is a significant link between COVID-19 recovery and fitness. Active travel can help us become more resilient."

That is why towns and cities in the UK and around the world are making or proposing radical changes to their roads to accommodate active travel.

We recognise this moment for what it is: a once in a generation opportunity to deliver a lasting transformative change in how we make short journeys in our towns and cities. According to the National Travel Survey, in 2017-18 over 40% of urban journeys were under 2 miles – perfectly suited to walking and cycling.

Active travel is affordable, delivers significant health benefits, has been shown to improve wellbeing, mitigates congestion, improves air quality, and has no carbon emissions at the point of use. Towns and cities based around active travel will have happier and healthier citizens as well as lasting local economic benefits.

The government therefore expects local authorities to make significant changes to their road layouts to give more space to cyclists and pedestrians. Such changes will help embed altered behaviours and demonstrate the positive effects of active travel. I'm pleased to see that many authorities have already begun to do this, and I urge you all to consider how you can begin to make use of the tools in this guidance, to make sure you do what is necessary to ensure transport networks support recovery from the COVID-19 emergency and provide a lasting legacy of greener, safer transport."

SCOTLAND - EMERGENCY LOAN FUND FOR SME HOUSEBUILDERS.

Housebuilders are now able to apply for short-term loans of up to £1 million from the Scottish Government to support them through the COVID-19 pandemic.

Small and medium-sized enterprises (SMEs) with liquidity issues due to the temporary closure of the housebuilding sector will be able to apply to a £100 million Scottish Government emergency loan fund.

The aims of this funds are:

- safeguard jobs and protect suppliers
- support post-coronavirus economic recovery and the continued supply of homes
- retain diversity of the housebuilding sector

SME housebuilders will be able to apply for loan support from 2pm on 18 May on the Scottish Government website. Full details on the criteria for the Fund will be available shortly.

Applicants should be a SME housebuilder with a turnover of £45 million or less per year, building five or more homes per annum. They should only apply for funding that is necessary for the short term. They will be asked to explain why existing support mechanisms are not sufficient for their business.

These loans have been capped at £1 million, most if the loans are expected to be repaid within two years with interest rates set at 2%. The minimum loan amount is £50,000.

SCOTLAND - CORONAVIRUS (COVID-19): BUSINESS SUPPORT FUND GRANT STATISTICS

By the end of 5th May 2020, Local Authorities reported that over 71,000 applications have been submitted for the Small Business Grant Scheme and the Retail, Hospitality and Leisure Business Grant Scheme across Scotland. Of these applications, 53,765 grants valuing £621m have been awarded.

The total number of reported applications fell between 28th April and 5th May. The fall is due to an improvement in reporting, with double counting significantly reduced now. As stated in previous publications, the number of applications reported represented a best estimate based on available

information and Scottish Government were aware that the reported number of applications for some local authorities included duplicate, resubmitted applications.

This occurred, for instance, when initial applications missed vital information such as bank details and some local authorities, using specific billing software, needed to ask applicants to resubmit forms. The billing software used by other local authorities allowed them to ask applicants to update information online, resulting in fewer or no duplicate applications in reported totals.

Almost all local authorities have now since removed or reduced the number of duplicate applications in reporting – presenting a more consistent measure of the number of applications received. Whilst Local Authorities have undertaken significant efforts to improve reporting, we advise that application totals still remain a best estimate for some Local Authorities.
